DELAWARE COUNTY 911 BOARD MINUTES June 3, 2008 DELAWARE COUNTY EOC

I. Chairman Homan called the meeting to order at 1:15 p.m. with the Pledge of Allegiance.

Chairman Homan acknowledged Jay Somerville from Dublin 911 and Lisa Iannotta from Delaware County HR as guests.

Glenn Evans asked the board to acknowledge Bill Shively to be excused due to schedule conflict.

- II. Minutes Motion by Glenn Evans and seconded by Chief Martin to approve the minutes as presented. Motion passed unanimously.
- III. Committee Report

<u>Technology Committee</u> – Chief Donahue reported that the Technology Committee met last week and that the have drafted revisions to the Gantt chart and the proposed consolidation costs. They are being reviewed by the 911 Committee. Once completed it will be brought to the 911 Board.

IV. Unfinished Business

a. <u>Job Description</u> – Chairman Homan stated that the applications have been distributed to all Board Members. Interviews are scheduled for July 1. Copies of the applications were distributed to all Board Members. Chairman Homan stated that an additional application was received after

the deadline. The Board agreed to disqualify the application as it was past due the deadline.

With the Board having the opportunity to previously review the applications, the attending Board members identified their top 5 picks. Discussion entailed whether the number should be increased in case of a drop out. During the discussion, Chief Farmer, who was late, presented his top candidates. The list was reassessed and the board identified the top 6 candidates as a result of a tie for # 5. (Ranking sheet attached).

Motion by Gary Vest and seconded by Sheriff Davis, that the top 6 applicants be accepted and brought in for the July 1 assessment. Motion passed unanimously.

Chairman Homan stated that Lisa Iannotta will be sending out letters to the candidates for the July 1 interviews. He questioned whether we would like the candidates to conduct a written questionnaire that would be brought with them to the interviews. This would provide an assessment of the writing capability and provide us the opportunity to obtain answers to specific questions. Examples of questions could be what would your entry plan be, or explain your leadership style.

Sheriff Davis stated that he was on-board with the process; however, felt that it was better if we did the process while the candidates were present. If we had the candidates do it prior to coming, we do not know that it is their work.

Chief Vest concurred and stated that each group could do one written question. Chief Honeycutt stated that it may be better that we allow them to answer the questions while they are present for the interviews, but not during the interview. The candidates will have plenty of time to complete while they are present.

Jay Somerville was asked about the process. Jay stated that the proposed process is a fair assessment. We are well ahead of the curve of the typical hiring process that characteristically has an interview. Jay stated that the interview and assessment will validate what we believe and know of the candidates.

Questions revolved around the background check. Sheriff Davis stated that he could do the fingerprinting; however, he is unable to commit the time and personnel to do the full background. Chief Vest asked if Delaware and Powell would commit Detectives to assist, could it get done. The Sheriff agreed that it would.

Chairman Homan stated that it is now time to begin compiling the questions for the interview. Glenn Evans asked if it was beneficial to have representatives from all three components be mixed together to provide diversity among the groups. Chief Vest stated that the reason why the interviews were set-up in the fashion they were was to have each group focus on their individual interests. Once that was completed and the groups put together their assessment, a true top candidate would emerge as it did through the process today. Glenn Evans stated that he felt there needed to be some consistency and standardization in the process. Sheriff Davis stated that the questions were another piece to the puzzle in determining the best candidate.

Steve Lutz asked in Lisa could facilitate in putting together the format for the assessment. Lisa Iannotta stated that she could. She further stated that each of the 3 groups have their own interests, and have separate questions, but there would need to be some common questions.

Chief Vest asked if there could be a designated Chair for each group and a scribe. Chairman Homan asked that all questions be submitted to Lisa by June 10. This will allow the final process to be completed by June 17 at our next Board Meeting.

The interview panel would consist of the following.

First Responders – Sheriff Davis, Chief Martin, Chief Honeycutt, Chief McIntire and Chief Farmer.

Administrative – Steve Lutz, Chairman Homan, a representative from the Commissioners Office and Townships.

Dispatchers – A dispatcher from the Sheriff's Office, County 911 Center and the City 911 Center.

Chairman Homan recapped the process and stated that the final program will be presented on June 17 to the Board.

- b. <u>Vision Statement</u> Chief Donahue stated that in light of the 911 Director that we wait and allow them the opportunity to develop. It was suggested that the creation of a vision statement could be one of the exercises in the process.
