New Business: The current job description for the 9-1-1 Director position was handed out. One of the updates going to be made will be under the job standards with certificates the candidate will need to have. Dawn Huston asked everyone to look over the description and make any edits/suggestion to be

considered and be returned by June 9, 2023. Sarah Dinovo will send out an email with the job description to the Administrative Board.

The applications will be vetted by the Administrative Committee, the County Administrator and the County HR department. Currently the Administrative Committee is made up of: Tom Homan (Delaware City Manager), Andy White (Powell City Manager), Gary Merrell (Commissioner), Jeff Balzer (Sheriff), Tracie Davies (County Administrator), Charles Miley (Trustee Representative) and Steve Hrytzik (Powell Police Chief). Ms. Davies suggested that the City of Powell's representative be replaced by a non-voting Fire Chief for the purpose of not creating a quorum of the full 911 Board. The by-laws currently states a quorum of the full board is represented by the Administrative Committee.

A motion was made by Tom Homan, seconded by Jeff Fishel to change the members of the Administrative Committee to replace Powell's City Manager with Chief Joe Ponzi (Genoa Township). A voice vote was called. All voted Aye.

There has not been an interim director selected yet.

No need for executive session.

Other business: Ms. Davies wanted to thank Patrick for all of his work in the Center and his dedication to the job. The sentiments were echoed around the room.
